IMPORTANT

The approval of an application for licence entitles an individual to become and Architect licensed by the Ontario Association of Architects (OAA).

In order to offer or provide architectural services to the public in Ontario, as defined in the <u>Architects Act</u>, an individual or entity must be the holder of a certificate of practice. The provision of architectural services, prior to the issuance of a licence and certificate of practice, may be prejudicial to the granting of a licence and/or a certificate of practice.

Until an application for a certificate of practice is approved by the Ontario Association of Architects (OAA), it is a contravention of the *Architects Act* to promote, offer, or provide architectural services in Ontario in the name of the new practice, and items such as letterhead, cheques, signs, etc. should not be ordered. The OAA must be notified in writing in advance of being considered for a commission in Ontario. Compliance with the requirements for licence must be undertaken immediately upon obtaining the commission.

The use of the term "certificate of practice" in this document shall always refer to a certificate of practice issued by the OAA unless otherwise stated.



General

When filing an application for licence, include the following:

- Completed, signed application for licence;
- Proof of Citizenship or lawful permanent residency status in the United States of America (USA) or Canada;
- Contact the National Council of Architectural Registration Boards (NCARB) to apply for a NCARB Certificate and/or have your current records updated; NCARB will send certificate directly to the OAA:
- Proof of licensure in good standing with one or more NCARB Participants (Member Boards) to the current Agreement (template attached);
- Signed affidavit attesting to the completion of 2,000 cumulative hours of post-licensure experience, practising as an architect in the USA (template attached);
- Payment of applicable fees (refer to Payment of Fees Form); and
- Completed, signed Consent Form (under PIPEDA).
- Allow approximately four to six weeks of processing time from the date of receipt of the completed application and all required documentation. An incomplete application will be delayed as it may be returned for completion. NOTE: ENSURE YOU HAVE ANSWERED ALL QUESTIONS OR YOUR APPLICATION WILL BE DEEMED INCOMPLETE.
- 2. All sections of the application are to be completed. The terms "Not Applicable" and "N/A" may be used where sections do not apply.
- 3. All documentation submitted will be verified.
- 4. The Licence term is January 1 to December 31 each year. The onus is on the OAA member to pay the fee within the time prescribed. Non-payment may lead to licence cancellation.
- 5. Applications received after December 1 will not be finalized in that calendar year (unless otherwise requested). Applicants should contact the Office of the Registrar after December 1 for information with respect to fees.
- 6. All documents prepared by an Architect licensed in Ontario that govern a project's construction, alteration, or enlargement must be sealed with an OAA seal issued to an Architect by the OAA. For more information regarding OAA professional seals, visit the OAA Website here.
- 7. Every OAA member shall display their licence certificate prominently in their place of business (Subsection 49(7), Regulation 27).
- 8. The OAA has a mandatory Continuing Education program. Detailed information can be found on the OAA Website.
- 9. There are application fees and annual fees for each licence and certificate of practice. These are set out on the separate Payment of Fees Form that are attached to the separate applications.



Completion of the Application

A. IDENTIFICATION

Question 7 requires proof of date of birth. Photocopies of birth certificate, passport, or driver's licence are accepted.

B. LICENCE HISTORY

Indicate licence status in all jurisdictions where a licence is currently held or was previously held. Identify any licence not currently in good standing and give the particulars. Attach supplementary sheets if necessary.

C. DECLARATION

The solemn declaration serves as a formal attestation by the applicant that all the information provided is truthful and accurate. This verification helps ensure the integrity of the registration process by preventing the submission of false information. Additionally, it holds the applicant legally accountable, as providing misleading details can result in legal consequences.

The declaration underscores the seriousness and professionalism of the application process. By signing, applicants confirm their understanding of and commitment to adhering to the relevant laws, regulations, and ethical standards governing their profession once licensed.

Where the Registrar proposes to refuse to issue a licence based on good character (which includes past conduct and the belief the applicant will not engage in the practice of architecture in accordance with the law, and with honesty and integrity) the *Architects Act* provides that the Applicant is entitled to a hearing by the Registration Committee. If the Applicant chooses to attend a hearing with the Registration Committee, they must deliver to the Registrar, within 30 days from the dated Notice of Proposal, a written notice of their intent to attend the hearing, coupled with the reasons that had been served upon them. A Decision by the Registration Committee may be appealed through the courts.



Mobility of Architects to Ontario

ARCHITECTURAL SERVICES IN ONTARIO can only be provided by an Architect licensed by the OAA and the holder of a certificate of practice issued by the OAA.

COMMISSIONS – Notify the OAA in writing in advance of being considered for a commission in Ontario. Comply with the requirements for licence immediately upon obtaining the commission. Do not practise architecture without a licence and certificate of practice in Ontario.

COLLABORATION AND TEMPORARY LICENCES – As an alternative to the process of licence as an Architect and issuance of a certificate of practice, or in the case of an Architect who is licensed in a jurisdiction that does not have reciprocity with the OAA, the process of Temporary Licence and Limited Certificate of Practice under Section 23 of the *Architects Act* is available for the purpose of providing architectural services on a **specific project**. This option requires collaboration with an Ontario Architect/holder.

Appendix 2 – Excerpts from the Mutual Recognition Agreement (Canada/USA)

The following is a summary of the requirements as set out in the Mutual Recognition Agreement (MRA) between the National Council of Architectural Registration Boards (NCARB) and the Regulatory Organizations for Architecture in Canada (ROAC) which took effect January 1, 2014. The below is for general referance purposes only and applicants should refer to the most current version of the agreement via the ROAC website.

1. Mutual Recognition Agreement

Definitions:

- (a) **Demonstration of Required Experience:** 2,000 cumulative hours of post-licensure experience shall be demonstrated by individual applicants through the provision of proof of licensure in good standing and a signed affidavit attesting to the experience.
- (b) **Principal Place of Practice:** The address declared by the Architect to be the address at which the Architect is predominantly offering architectural services. The Architect may only identify one principal place of practice.
- (c) **Limitations:** Nothing in the agreement limits the ability of an NCARB Member Board or ROAC jurisdiction to refuse to license/register an Architect or impose terms, conditions, or restrictions on their licence/registration.

2. Eligibility and Conditions

All applicants for registration in the Province of Ontario, and all architectural practices, must comply with the local requirements.

A. Eligibility

- (a) Architects able to benefit from the provisions of this agreement must be citizens of the United States or Canada or have lawful permanent residency status in either country in order to seek licensure/registration under this Agreement. Architects shall not be required to establish citizenship or permanent residency status in the host country in which they seek licensure/registration under this Agreement.
- (b) Architects must also be licensed/registered in a signatory jurisdiction of their home country and must have completed at least 2,000 hours of post-licensure/registration experience practising as an Architect in their home country.
- (c) Architects who have been licensed by means of a Broadly Experienced Foreign Architect (BEFA) program of either two countries or other foreign reciprocal licensing agreement are not eligible under this agreement.

B. Conditions

U.S. Architect to Canadian Jurisdiction

Upon application, those ROAC jurisdictions who are signatories to this Agreement and so long as they remain signatories agree to license/register as an Architect in their respective province or territory any Architect who:

- (a) Is currently licensed/registered in good standing by one or more NCARB Member Board(s) that is a current signatory to this Agreement;
- (b) Holds a current NCARB Certificate;
- (c) Meets the eligibility requirements listed above; and
- (d) Whose principal place of practice is in a jurisdiction that is a current signatory to this Agreement.

C. Applicant Must Provide:



- (a) a letter of good standing from the architectural licensing authority in the Architect's principal place of practice (template attached);
- (b) a letter of declaration from the applicant attesting to at least 2,000 hours of post-licensure experience (template attached); and
- (c) proof of citizenship/permanent residency.

3. Practice (Certificate of Practice)

- (a) To promote, offer, or provide architectural services in Ontario, a registered Architect must apply for and have approved a certificate of practice.
- (b) In order to obtain and continue to hold a certificate of practice, a registered Architect under the Mutual Recognition Agreement must maintain their Principal Place of Practice in a jurisdiction that allows an OAA member to become registered on a reciprocal basis.
- (c) In order to hold a certificate of practice, a registered Architect is subject to the local requirements including those relating to professional liability insurance coverage.

Permissible forms of practice are set out in the *Architects Act*, R.S.O. 1990, c. A. 26 and Regulations. Information is available from the Office of the Registrar at 416-449-6898.
