The London Society of Architects was quiet in 2021, with few actions or engagement of members. The OAA President's Meeting with LSA and WRSA was a notable exception and was a welcomed opportunity for LSA members to re-engage, even with the limitations of a virtual format. LSA looks forward to future OAA President's Meetings in-person that have previously been well attended and are a highlight social event for LSA.

Through the year, LSA remained active in planning for a new season of its architecture speaker series, an annual fall and winter series of speakers and films held at Museum London. Pandemic uncertainties precluded the scheduling of speakers and venue in 2021, and a virtual series was not considered to be a valuable alternative. With 2022 appearing to open up to in-person events, LSA will prepare for a return of the speaker series with an engaging lineup of speakers and films.

LSA is a stakeholder in the City of London building and development initiatives, facilitated by the City through the Building Development Liaison Forum. Most initiatives and the forum were paused through the pandemic but have recently resumed in 2022. Key initiatives that are resuming include rethinking and updating the City's zoning by-law, facilitating climate emergency action in building and development, enabling solutions to housing challenges, and improving site plan approval and building permit application timelines. LSA will be mobilizing its members to participate in the related committees of these initiatives to help create solutions and to advocate in the public interest.

Prior to the pandemic, LSA was developing a network of intern architects to facilitate assistance and collaboration on the path to licensure. This was curtailed by the pandemic and plans are in place to resume in 2022.

LSA is working on creating a new website, to meet current needs of LSA members and the public. LSA has secured a vendor to develop the website, and in 2022 LSA will define website details, prepare for rollout, and will engage members to contribute rollout content.

LSA has periodically hosted casual social events for members as an opportunity to connect. This was paused through the pandemic, and LSA will be planning social events as soon as practical to bring LSA members back together in 2022.

2021 was a quiet period for LSA, however we are looking forward to re-engaging with members and the public gradually through 2022.
