## Proposed Changes to 2020 National Model Codes: Public Review

Until **July 29**, you can participate in the **public review of proposed changes** to the 2020 National Model Codes. As detailed by the Canadian Board for Harmonized Construction Codes (CBHCC), topics include climatic loads, residential energy efficiency, and accessibility. These changes are expected to find their way into a future version of Ontario's Building Code.
