New CCDC Contracts Now Available in Electronic Format


The <u>Canadian Construction</u>

Toronto's Rental Renovation License Bylaw in Effect Next Week

On **July 31**, **2025**, the City of Toronto's **Rental Renovation Bylaw** will be implemented. Established to protect tenants from bad faith evictions, preserve the City's rental housing stock, and establish a transparent and equitable process for landlords to complete necessary renovations responsibly, the bylaw requires landlords to obtain a licence before starting work in instances where vacancy of rental units is deemed necessary for the work being undertaken.

As part of the licence application, landlords have to obtain a report from a "qualified person"—that is, an individual licensed by the OAA or Professional Engineers Ontario (PEO)—to confirm vacant possession is required.

Changes to Ontario Fire Code and French Edition Available

On June 2, 2025, the Solicitor General of Ontario approved <u>Ontario Regulation</u> <u>87/25</u> made under the *Fire Protection and Prevention Act, 1997* (FPPA), which introduces changes to the Ontario Fire Code (<u>O. Grenfell Tower Fire: Lessons from an Architectural Catastrophe

On June 14, 2017, Grenfell Tower in North Kensington, London, England, was engulfed in flames, resulting in the tragic loss of 72 lives. The final report of the Grenfell Tower Inquiry was published in September 2024, and the inquiry officially closed in February 2025.

OAA Issues Statement on *Bill 17, Protect Ontario by Building*Faster and Smarter Act

As reported in *OAA News*, Ontario passed Bill *17, Protect Ontario by Building Faster and Smarter Act, 2025*, which includes changes to the *Planning Act*, such as amending complete application rules to limit what can be required as part of a complete application. A regulation under the Act excludes:

- sun/shadow reports;
- wind reports;
- · urban design reports; and
- lighting reports.

It also updates the *Building Code Act* to prevent municipalities from passing bylaws respecting the construction or demolition of buildings. To read the OAA's statement, **click here**.
