

Infrastructure Ontario Expected to Release Supplementary Conditions to OAA 600-2021

After 18 months of discussion, Infrastructure Ontario (IO) has confirmed the government has approved a final set of supplementary conditions (SCs) for use with OAA 600-2021, specifically for IO projects, primarily in the real estate sector. However, the official implementation date is still pending confirmation from IO. Also approved were IO SCs for CCDC 2 and CCDC 31.

New CCDC Contracts Coming in June 2025 on Construction Management and IPD

The <u>Canadian Construction Documents Committee</u> (CCDC) is <u>expected to</u> <u>release new versions</u> of the key CCDC 5A, 5B, and 17 for construction management contracts, as well as the CCDC 30 Integrated Project Delivery Contract.
